For every NMA research project, a Human Research Ethics Application (HREA) form must be submitted electronically, with supporting documents, to the reviewing HREC.

#### Information for Section B

For each site in a NMA research project, a research governance application must be submitted electronically, with supporting documents, to the site's Research Governance Office.

Details of the research governance application form and submission arrangements in each state/territory are available in the <u>NMA Standard Principles of Operation</u> and <u>NMA Fact Sheet</u>.
